

# Perry Farmers' Market Application and Agreement

## 2020 Summer Season: July 2<sup>nd</sup> – September 24<sup>th</sup> Thursdays 4-7pm in Downtown Perry

This form must be completed and accompanied with the following items before a market vendor stall will be assigned:

1. **Certificate of Liability Insurance** (minimum coverage of \$300,000)
2. **Copy of any required state licenses, permits and/or certifications**
3. **Payment in FULL** – check payable to Perry Chamber (Memo Line: Summer Farmers Market)  
**Vendor Fee: \$30 for Full Season (13 weeks) or \$10/Market for Occasional Vendors**

Approved vendors will be assigned to designated vendor spaces (one parking stall). Space is limited and preference will be given to returning full-season vendors with food products. Occasional Vendors are not guaranteed space but may apply with requested dates. Market Manager retains the right for final vendor approval and placement.
