

## City of Perry Tire Drop Off – June 11<sup>th</sup>

The City of Perry will collect tires on Saturday, June 11<sup>th</sup> from 8 a.m. until noon at the Perry Recycle Center located at 14325 Ivy Place. There will be no charge to dispose of the first five car tires. A cost of \$1.00 will be charged to dispose of each additional car tire.

The disposal cost for large truck and tractor tires will be \$5.00 each. All tires must be removed from the rims. Please note: This is for residential use only. Tires from businesses will not be accepted. Please call City Hall at 515-465-2481 if you have any questions.

## City of Perry Household Hazardous Waste Drop Off – July 16<sup>th</sup>

The City of Perry will collect household hazardous waste on Saturday, July 16<sup>th</sup> from 9 a.m. until noon at the Police Station/Fire Station parking lot located at 908 Willis Avenue. Items Accepted include Antifreeze, Batteries (only

rechargeable), Cleaners, Fertilizers, Fluorescent Light Bulbs (CFLs), Glues, Gasoline and Kerosene, Motor Oil (used), Oil Filters (used), Oil Based Paint, Pesticides, Poison, Pool Chemicals, Varnishes, Roofing Tar, Mercury Thermometers, Stains, Vegetable Oil, Weed Killers and Windshield Fluid. Items Not Accepted include ammunition, asbestos, electronics, explosives, fire extinguishers, latex paint, medications, propane tanks and radioactive materials.

## No Grass Clippings in the Streets/Alleys

Citizens are reminded that it is illegal to mow or place grass, leaves and other yard waste into the public streets.

City of Perry Code of Ordinances 135.03 states “It is unlawful for any person to throw or deposit on any street or alley any ... grass, leaves, yard waste or debris ... which, if washed into the storm sewer, could clog the storm sewer. The Police Department and Public Works Department will monitor and enforce this regulation.”

Besides clogging the storm sewers, grass clippings in the streets can be slick, which causes a safety hazard to motorcyclists and bicyclists.

Be a good neighbor and make certain that you don't leave clippings in the street. Use a blower and blow them back into the yard, use a broom to sweep them up, or cut in a manner that the grass gets thrown away from the street. Please call City Hall at 515-465-2481 to report any compliance issues.

## Park Shelter Rentals at Pattee and Wiese Parks

Individuals are able to reserve the shelters at Pattee and Wiese Parks from April 1<sup>st</sup> to September 30<sup>th</sup> each year.

The rent for all shelters at Pattee Park and the shelter and gazebo at Wiese Park are \$50 per day.

Alcohol permits are available to be purchased for an extra \$25 fee with at least a 2 week notice. Photo ID is required and the applicant must be able to pass a background check. No children may be present.

## Fireworks Not Allowed in Perry City Limits

**IT IS ILLEGAL for any person to use or explode any explosive material or consumer fireworks within Perry city limits.**

The City of Perry deems the use of consumer fireworks as a threat to public safety or a nuisance to landowners and therefore prohibits the use of consumer

fireworks within Perry city limits, except for commercial displays by a licensed operator that have received a permit from the City of Perry.

The penalty for violation of this ordinance is a simple misdemeanor punishable by a fine of not less than two hundred and fifty dollars (\$250). A municipal infraction of \$250 may be issued in lieu of the simple misdemeanor violation.

## Perry Dog Park Rules and Regulations

Yearly passes for the Perry Dog Park are available at the McCreary Community Building, 1800 Pattee Street. The fee is \$20 for the first dog and \$10 for each additional dog, with a limit of three dogs. Perry residents must have a current pet license in order to purchase a dog park permit. Day passes are also available for \$2 per dog.

Please be aware of the rules for usage of the Perry Dog Park:

- Clean up after your dog.
- No prong or choke collars.
- No food except for small, training treats.
- No dogs under 6 months or female dogs in heat.

- Dogs must be under the control of the handler at all times.
- No aggressive dogs and if a dog shows aggression, they must be removed from the dog park.
- Violators will be subject to removal from the park and suspension of park privileges.
