### **ORDINANCE NO. 963**

# AN ORDINANCE AMENDING THE CITY CODE OF PERRY, IOWA, BY AMENDING CHAPTER 125 (FIREWORKS)

WHEREAS, the General Assembly of the State of Iowa has taken measures to allow the sale and use of consumer fireworks in the State of Iowa during specific timeframes and pursuant to applicable state licensure; and

WHEREAS, the legislation provides for city councils, by ordinance, to prohibit or limit the use of consumer fireworks within their jurisdiction, if determined a public safety risk or a nuisance to neighbors.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of Perry, Iowa as follows:

**SECTION 1. AMEND CHAPTER 125 (FIREWORKS).** The Code of Ordinances of the City of Perry, Iowa, is amended by repealing Section 125 and adopting the new section stated as follows:

#### 125 FIREWORKS

The sale, use or exploding of fireworks within the City is subject to the following:

1. **Definition.** For purposes of this section, definitions are enumerated in the Iowa Code section 727.2, which definitions are incorporated herein by reference.

(Code of Iowa, Sec. 727.2)

## 2. Sales:

- A. All Consumer Fireworks Sellers must abide by the licensing requirements and rules for sales as set by the State of Iowa.
- B. All Consumer Fireworks Sellers must complete the City of Perry's information request form, providing proof of liability insurance, State of Iowa's Retail License, and sales tax permit as well as site maps.
- 3. **Fireworks Discharging Regulations:** The City of Perry deems the use of consumer fireworks as a threat to public safety or a nuisance to landowners and therefore prohibits the use of consumer fireworks within the Perry City limits, except for commercial displays that have received a permit from the City of Perry.
- 4. **Permitting of Display Fireworks:** The City may, upon application in writing, grant a permit for the display of display fireworks by a City agency, fair associations, amusement parks and other organizations or groups of individuals approved by the City Council when such fireworks display will be handled by a competent operator. A competent operator is an individual who has been trained in the proper use of display fireworks and holds a valid pyrotechnics license. No permit shall be granted hereunder unless the operator or

sponsoring organization has filed with the City evidence of insurance in the following amounts:

Personal Injury: \$250,000.00 per person
 Property Damage: \$50,000.00 per person

3. Total Exposure: \$1,000,000.00

- 5. **Violations.** The penalty for a violation of this chapter is a simple misdemeanor punishable by a fine of not less than two hundred and fifty dollars \$250. A Municipal Infraction of \$250 may be issued in lieu of the simple misdemeanor violation.
- 6. **Exceptions.** This section does not prohibit the sale by a resident, dealer, manufacturer or jobber of such fireworks as are not prohibited; or the sale of any kind of fireworks if they are to be shipped out of State; or the sale or use of blank cartridges for a show or theater, or for signal purposes in athletic sports or by railroads or trucks for signal purposes, or by a recognized military organization. This section does not apply to any substance or composition prepared and sold for medicinal or fumigation purposes.

**SECTION 2. REPEALER**. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of this ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 4.** WHEN EFFECTIVE. This ordinance shall be effect from and after its final passage, approval and publication as provided by law.

5, Violations. The penalty for a violation of this chapter is a simole misdemeanor nuclishable by a fine of not less than two hundred and fifty dollars \$250. A Municipal infraction of \$250 may be issued in lieu of the simple misdemeanor violation.

6. Exceptions. This section does not prohibit the sale by a resident, dealer, manufacturer or jobber of such fireworks as are not prohibited; or the sale of any kind of fireworks if they are to be shipped out of State; or the sale or use of blank cartridges for a show or theater, or for signal purposes in athletic sports or by railroads or tracks for signal purposes, or by a recognized military organization. This section does not apply to any substance or composition prepared and sold for medicinal or fumigation purposes.
